
# LIFE CHANGING LEGACY

Whether it be a friend, a family member or a colleague, we all know someone impacted by at least one of these conditions. That means we all know someone who can benefit from funding research in these areas.




# The impact of your generosity

**Ground-breaking research** that has the opportunity to change lives, save lives and improve the quality of life for people impacted by heart disease, lung disease, mental health and dementia.


**Innovative equipment** to support patients at The Prince Charles Hospital, Caboolture Hospital and within our research labs.

# Declaration: Suggested Wording

#### 1. GENERAL

"I GIVE to The Prince Charles Hospital Foundation, presently located at Rode Road, Chermside, [the whole of my estate/ the sum of \$ / (proportion) of my Estate/ a particular asset] free of all duties and charges to be used at the discretion of The Prince Charles Hospital Foundation. I DIRECT that the receipt of the secretary or treasurer for the time being of The Prince Charles Hospital Foundation shall be a complete discharge for my Trustee who shall not be required to see the application of the gifts."

#### 2. SPECIFIC GIFT

"I GIVE to The Prince Charles Hospital Foundation, presently located at Rode Road, Chermside, [the whole of my estate/ the sum of \$ / (proportion) of my Estate/ a particular asset], free of all duties and charges to be used at the discretion of The Prince Charles Hospital Foundation for purposes of purchasing <equipment/ for research/ for xxxx>. I DIRECT that the receipt of the secretary or treasurer for the time being of The Prince Charles Hospital Foundation shall be a complete discharge for my Trustee who shall not be required to see the application of the gifts."
