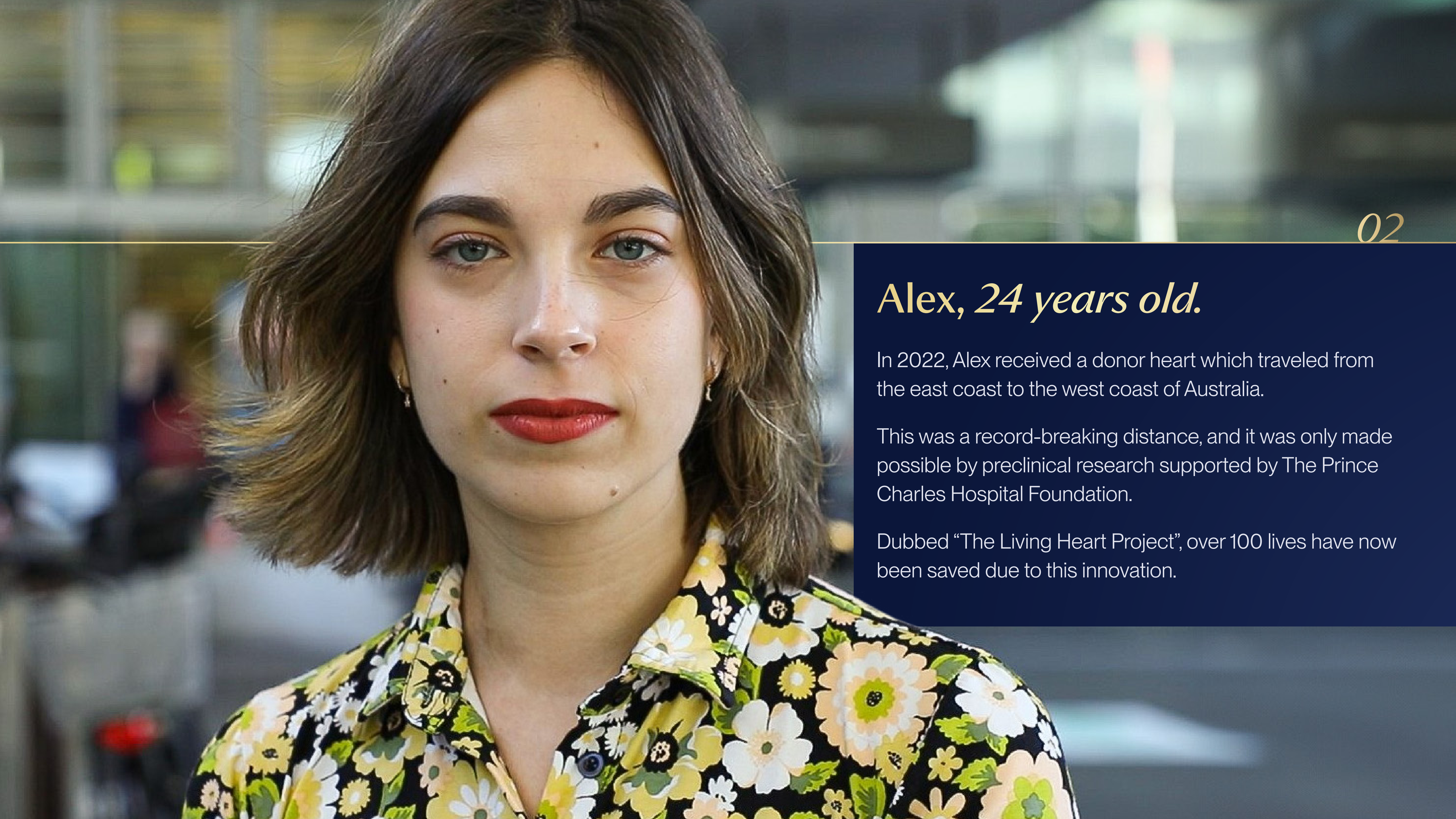

Professional Advice

When writing your Will, it is advisable to **seek professional advice** so that your wishes will be honoured. You may find the following wording on the next few pages helpful.

How you can direct your contribution

- 1. General purposes to be determined by the Foundation, or**
- 2. Equipment purposes, or**
- 3. Specific research purposes**

Declaration: Suggested Wording

10

1. General

“I GIVE to The Prince Charles Hospital Foundation, presently located at Rode Road, Chermside, [the whole of my estate/ the sum of \$___/ (proportion) of my Estate/ a particular asset] free of all duties and charges to be used at the discretion of The Prince Charles Hospital Foundation. I DIRECT that the receipt of the secretary or treasurer for the time being of The Prince Charles Hospital Foundation shall be a complete discharge for my Trustee who shall not be required to see the application of the gifts.”

2. Specific Gift

“I GIVE to The Prince Charles Hospital Foundation, presently located at Rode Road, Chermside, [the whole of my estate/ the sum of \$___/ (proportion) of my Estate/ a particular asset], free of all duties and charges to be used at the discretion of The Prince Charles Hospital Foundation for purposes of purchasing <equipment/ for research/ for xxxx>. I DIRECT that the receipt of the secretary or treasurer for the time being of The Prince Charles Hospital Foundation shall be a complete discharge for my Trustee who shall not be required to see the application of the gifts.”
